

## PRIVACY POLICY

In accordance with the French Data Protection Act of 6 January 1978, amended in 2004, you have the right to access and rectify information concerning you, which you can exercise by contacting the website administrator via email at the following address: [info@ecolodge-france.com](mailto:info@ecolodge-france.com).

This activity has been declared to the CNIL.

The collection of your email is used by "www.ecolodge-france.com" in order to respond to your request or to confirm a reservation. Your data will remain confidential and will not be sold to third parties. All emails sent contain an unsubscribe link that allows you to stop receiving messages.

In addition, on 24 May 2018, the SARL 100% PURE AUVERGNE crashed all its databases to invite you to re-register if you wish to continue to be kept informed of the news at the "instants d'Absolu" Ecolodge & Spa through the seasonal newsletter, emailings of special offers or if you should like to download the White Paper of Happiness (downloading not linked to the saving of your own details except if you clearly expressed such wish).

### **Personal data management:**

In France, personal data is protected in particular by Act No. 78-87 of 6 January 1978, Act No. 2004-801 of 6 August 2004, Article L. 226-13 of the Criminal Code and the European Directive of 24 October 1995.

When using the site "www.ecolodge-france.com", are likely to be collected according to the company's communication actions: the URL of links through which the user accessed the site "www.ecolodge-france.com", the user's access provider, the Internet Protocol (IP) address of the user.

In any case the SARL 100% PURE AUVERGNE collects personal information relating to the user only for the need of certain services provided by the site "www.ecolodge-france.com". The user provides this information in full knowledge, particularly when he/she enters it himself in the case of a holiday booking. It is specified to the user of the site "www.ecolodge-france.com" the obligation or not to provide this information.

In accordance with the provisions of articles 38 and following of the law 78-17 of January 6, 1978 relating to data processing, files and freedoms, any user has a right of access, rectification and opposition to personal data concerning him/her, by making a written and signed request, accompanied by a copy of the identity document with signature of the holder of the document, specifying the address to which the reply must be sent.

No personal information of the user of the site "www.ecolodge-france.com" is published without the user's knowledge, exchanged, transferred nor sold on any medium to third parties. Only the assumption of the repurchase of the SARL 100% PURE AUVERGNE and its rights would allow the transmission of the said information to the possible purchaser who would be in his turn held of the same obligation of conservation and modification of the data with respects to the user of the site "www.ecolodge-france.com".

The databases are protected by the provisions of the law of 1 July 1998 transposing Directive 96/9 of 11 March 1996 on the legal protection of databases. These provisions are reinforced by the latest legislation that came into force under the name of the DGPR.

#### **Hypertext links and cookies:**

The creation of hypertext links to the "www.ecolodge-france.com" site is subject to the prior agreement of the Director of Publication.

The site "www.ecolodge-france.com" contains a certain number of hypertext links towards other websites, set up with the authorization of the SARL 100% PURE AUVERGNE. However, 100% PURE AUVERGNE SARL does not have the possibility to check the content of the sites thus visited on a daily basis, and will therefore not assume any responsibility for this fact.

Browsing the "www.ecolodge-france.com" site may cause cookies to be installed on the user's computer. A cookie is a small file, which does not allow the identification of the user, but records information relating to the navigation of a computer on a site. The data thus obtained are intended to facilitate subsequent navigation on the site, and are also intended to allow various measures of attendance.

Refusal to install a cookie may make it impossible to access certain services. The user can however configure his computer in the following way, to refuse the installation of cookies:

Under Chrome: Settings menu / Show advanced settings / Privacy / Content settings / Block all cookies.

Under Internet Explorer: tool tab / internet options. Click on Privacy and choose Block all cookies. Confirm with Ok.

Under Netscape : editing tab / preferences. Click on Advanced and choose Disable cookies. Confirm with Ok.

#### **Right of reply:**
